**CALL MEETING TO ORDER**

**ACTION:** Beery-Burggraff called the meeting to order at approximately 4:31 p.m.

Staff was informed the first (1<sup>st</sup>) bid was from Sonsray with the asking price of \$86,475.00 and the second (2<sup>nd</sup>) bid was from Cashman Equipment, asking price of \$87,426.00. Time was given to staff and agenda item tabled until staff completed it's over view. After careful consideration the vote was to go with Sonsray loader. Sweeney stated he would contact the manufacturer in regards to the decision.

**STREETS AND HIGHWAYS UNDER ITS JURISDICTION AND WITHIN THE REASONABLE EXERCISE OF ITS POLICE POWERS**

Sweeney explained to board members that most recently the Town of Tonopah adopted the following NRS allowing for off road vehicles to access all roads within town limits either to gain access or exiting town. Sweeney is in support of the ordinance and feels that it will allow for more clarity. Deputy Cathcart, in attendance, is also in support of this ordinance making it much clearer in terms of the law and its authority to regulate off-road vehicle use within town limits.
