## CLASS TITLE: CHIEF DEPUTY DISTRICT ATTORNEY - CRIMINAL

### BASIC FUNCTION:

Under the direction of the District Attorney, responsible for administering the conduct of legal research work and litigation in court: work includes discussing, researching and preparing for the prosecution of defendants for Nye County as well as defending and prosecuting criminal litigation to which the County is a party. General supervision is exercised over all employees in the office and work is performed with latitude for independent judgment and action and is reviewed by the District Attorney through evaluation of results obtained. Prepares legal opinions for government officials; provides legal assistance and advice to government boards while in attendance.

### REPRESENTATIVE DUTIES: *(Performance of these functions is the reason the job exists.*

*Assigned job tasks/duties are not limited to the representative duties).*

1. Discusses, researches and prepares for the legal prosecution of defendants in the courts of the State of Nevada; provides legal guidance, advice and direction to the other Deputy District Attorneys regarding the conduct of the prosecutions;
2. Assists in the coordination of the activities of the Office of the District Attorney with those of Court, Public Defender and the Attorney General; coordinates the office of the District Attorney's activities in the various courts of the State of Nevada.
3. Researches, interprets, and applies laws and court decisions in the preparation of briefs and pleadings in connection with trials, other legal proceedings.
4. Assists in the preparation and presentation of cases taken before the Supreme Court; interviews witnesses and other interested persons regarding cases.
5. Instructs investigators as to what information is required on pending cases; evaluates information as to possible use in court cases.
6. Represents the Office in the absence of the District Attorney.
7. Researches request for legal opinions from other County departments and officials and prepares written and oral legal opinions in response.
8. Coordinates functions of the District Attorney's Office with the functions of the police agencies in regard to investigation and prosecution of criminal matters.
9. Provides training and direction to Deputy Attorneys, reviews and critiques written work of Deputies.
10. Prepares and presents evidence and arguments for the prosecution of difficult felony cases involving multiple defendants and multiple charges, and having serious consequences of error, or a high degree of public interest, and major violators.
11. Negotiates with defense counsel regarding the disposition cases or modification of charges.

12. Directs the prosecution of major or highly complex criminal cases.
13. Prosecutes, negotiates, and assists with UIFSA/DCFS, juvenile caseload, and misdemeanor bench trials.
14. Coordinates witnesses, victims, experts, and investigators at all states of prosecution.
15. Conducts media conferences consistent with office policy.
16. Reviews and works with NCJIS policy and procedure in coordination with the office TAC and ATAC in accordance with state and federal guidelines.
17. Prepares complex, appellate work and other post conviction remedies sought, as well as represents the Nye County District Attorney's Office at parole hearings when necessary.
18. Maintains caseload of criminal prosecutions.

**EDUCATION AND EXPERIENCE:**

Any combination of training, education, and experience that would provide the required knowledge and abilities. A typical way to gain the required knowledge and ability is: graduation from accredited school of law, admission to the Nevada State Bar; experience directly related to the duties and responsibilities of the class and eligibility to practice law in the State Courts of Nevada, the U.S. District Court, District of Nevada and the U.S. Court of Appeals for the Ninth Circuit.

**LICENSES:**

Valid Nevada driver's license appropriate for equipment to be operated. Admission to the Nevada State Bar.

**WORK DIRECTION, LEAD AND SUPERVISORY RESPONSIBILITIES:**

Deputy District Attorneys, secretarial staff, investigators and Support Enforcement Division.

**CONTACTS:**

Supervisor, co-workers, other County department personnel, public, court staff, witnesses, government officials, and sheriff's representatives.
