

1 NYE COUNTY RESOLUTION NO. 2017-61

2 A RESOLUTION AUTHORIZING THE SUBMISSION OF NOTICE TO THE UNITED STATES DEPARTMENT
3 OF THE INTERIOR, BUREAU OF LAND MANAGEMENT THAT NYE COUNTY REQUESTS A DIRECT
4 SALE FOR THE REAL PROPERTY COMMONLY KNOWN AS THE SILVER STATE SHOOTING PARK
5 LOCATED NEAR BEATTY, NV FOR USE AS A SHOOTING PARK AND AUTHORIZING THE CHAIRMAN
6 TO EXECUTE ALL DOCUMENTS AND TO TAKE SUCH OTHER ACTIONS AS REQUIRED TO SECURE
7 ISSUANCE OF THE SUBJECT LAND.

8 WHEREAS, the Recreation and Public Purposes Act (68 Statute 173; 43 U.S.C 869 et. Seq.) ("Act")
9 authorizes the lease or sale of public lands for recreational or public purposes to state and local governments; and

10 WHEREAS, on August 16, 2011 the Nye County Board of County Commissioners ("Board") approved
11 requesting a direct land sale for the Silver State Shooting Park more particularly described in Exhibit A; and


12 WHEREAS, the Board has determined that the interests of the County and the public would be served
13 through issuance by the BLM of a direct land sale conveying title to the County subject to certain restrictions as
14 specified in the Act.

15 NOW, THEREFORE, BE IT RESOLVED by the Nye County Board of County Commissioners as follows:


- 16 1. Authorize submission of notice to the United States Department of the Interior, Bureau of Land
17 Management that Nye County requests a direct sale for property commonly known as the Silver
18 State Shooting Park located near Beatty, NV more particularly described in Exhibit A.
- 19 2. Authorize the Chairman of the Board to execute all documents and to take other such actions as
20 required to secure issuance of the subject land.
