5 WHEREAS, on June 6, 2017 the Nye County Board of County Commissioners amended Title 9,  
6 titled Peace, Morals and Welfare, Chapter 9.20 Prostitution, which said Chapter places fee requirements  
7 to be adopted by Resolution, and

8 WHEREAS, fees shall be set by resolution;


9 NOW, THEREFORE, BE IT RESOLVED by the Nye County Board of County Commissioners

**Exhibit A**

**Title 9 Fee Schedule of Application, Licensing and Registration Fees**

**A. Application Fee:** **\$5,000.00**

**B. Amended Application Fee:** **\$1,500.00**

**C. License Fee:**

1. For an operation for which the licensee declares that during that quarter, or any portion thereof, from one to and including five (5) prostitutes will be working on the floor at that operation at any one time, two thousand three hundred forty-three dollars and seventy-five cents (\$2,343.75);
2. For an operation for which the licensee declares that during that quarter, or any portion thereof, from six (6) to and including ten (10) prostitutes will be working on the floor at that operation at any one time, four thousand three hundred seventy-five dollars (\$4,375.00);
3. For an operation for which the licensee declares that during that quarter, or any portion thereof, from eleven (11) to and including twenty-five (25) prostitutes will be working on the floor at that operation at any one time, nine thousand three hundred seventy-five dollars (\$9,375.00);
4. For an operation for which the licensee declares that during that quarter, or any portion thereof, twenty-six (26) or more prostitutes will be working on the floor at that operation at any one time, forty-six thousand eight hundred seventy-five dollars (\$46,875.00).

**D. Registration Fee:**

**1. Quarterly Fee:** **\$150.00**

**2. Annual Fee:** **\$150.00**
