

1 **NYE COUNTY RESOLUTION NO. 2017-80**

2 **A RESOLUTION AUTHORIZING A MEDIUM-TERM OBLIGATION**

3        WHEREAS, at the regular meeting of the Board of County Commissioners of Nye County, State  
4 of Nevada, held the 7th day of November, 2017, a discussion that the public interest requires the  
5 Medium-Term Obligation was had; and

6        WHEREAS, proper notice was given of the intention to act upon this Resolution Authorizing a  
7 Medium-Term Obligation pursuant to NRS 350.087 and NAC 350.100 through 350.160; and

8        WHEREAS, the Board finds that the public interest requires the Medium-Term Obligation  
9 pursuant to NRS 350.087(2)(a); and

10       WHEREAS, pursuant to NRS 350.087(2)(b), the facts upon which the finding that the public  
11 interest requires the Medium-Term Obligation were determined to be as follows:

12       WHEREAS, the General Fund is unable to support payment from the General Fund to repay the  
13 cleanup activities at the Tonopah Public Works Buildings 1 & 2, 377 North Jackson Street, Tonopah,  
14 NV, of \$200,000.00 within sixty (60) months following the month in which the loan was made pursuant  
15 to NAC 350.150; and

16       WHEREAS, pursuant to NRS 350.087(2)(c)(1), the source of revenue that is anticipated to be  
17 used to repay the Medium-Term Obligation is from the Special Capital Projects Fund (10402); and

18       WHEREAS, pursuant to NRS 350.087(2)(c)(2), five (5) consecutive annual payments in the  
19 amounts of \$ 43,670.91 is anticipated to be available to repay the Medium-Term Obligation from the  
20 Special Capital Projects Fund (10402); and

21       WHEREAS, pursuant to Nevada Administrative Code 350.140, interest rate of 3.00% will be  
22 charged on the Medium-Term Obligation; and

23       WHEREAS, proper notice was given of intention to act on the Resolution Authorizing a  
24 Medium-Term Obligation pursuant to Nevada Revised Statutes 350.087 and Nevada Administrative  
25 Code 350.100 through 350.160; and

1           WHEREAS, pursuant to NRS 350.087, the Board adopted by at least two-thirds vote of its  
2 members the Resolution Authorizing a Medium-Term Obligation as follows:


7           NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Nye  
8 County proposes to borrow a sum not to exceed \$200,000.00 with an interest rate of 3.00%. The purpose  
9 for which the funds are to be used is for cleanup activities at the Tonopah Public Works Buildings 1 &  
10 2, 377 North Jackson Street, Tonopah, NV. The Medium-Term Obligation will be repaid from Special  
11 Capital Projects Fund (10402). The dollar amount available to repay the Medium-Term Obligation from  
12 Special Capital Projects Fund (10402) is \$218,354.57.

13           IT IS FURTHER RESOLVED, pursuant to Nevada Administrative Code 350.120, the Nye  
14 County Clerk forward the necessary documents to the Executive Director, Department of Taxation,  
15 Carson City, Nevada.
