

1 **NYE COUNTY RESOLUTION NO. 2018-02**

2 A RESOLUTION DIRECTING THE LEVY OF A SPECIAL ASSESSMENT ON EACH WATER
3 USER SITUATED WITHIN THE CONFINES OF THE DUCKWATER CREEK GROUNDWATER
BASIN FOR FISCAL YEAR 2018-2019

4 WHEREAS, pursuant to NRS 533.280, 533.285 and 533.290 the Nye County Board of County
5 Commissioners (Board) is required to fund the 2018-2019 budget for Nevada State Water Engineer's
6 supervision over of the Duckwater Creek Groundwater Basin; and


7 WHEREAS, in order to generate the revenue needed to fund the budget the Board must levy a
8 special assessment within the confines of the Duckwater Creek Groundwater Basin as prorated and
9 assessed against each water user, which must be based upon the proportion which the water right of that
10 water user bears to the aggregate water rights in the Duckwater Creek Groundwater Basin, which said
11 special assessment will generate approximately \$9,330.00.


12 NOW THEREFORE, BE IT RESOLVED, that effective for the 2018-2019 fiscal year there is
13 hereby imposed a special assessment as prorated and assessed against each water user who has a permit
14 to appropriate water or perfected water right within the Duckwater Creek Groundwater Basin, to appear
15 and be collected with the first quarter tax billing, which said special assessment shall be a lien upon the
16 property.
