

1 **NYE COUNTY RESOLUTION NO. 2018-09**

2 A RESOLUTION DIRECTING THE LEVY OF A SPECIAL ASSESSMENT ON EACH WATER  
3 USER SITUATED WITHIN THE CONFINES OF THE BIG SMOKY VALLEY - NORTHERN PART  
GROUNDWATER BASIN FOR FISCAL YEAR 2018-2019

4 WHEREAS, pursuant to NRS 534.040 the Nye County Board of County Commissioners (Board)  
5 is required to fund the 2018-2019 budget for Nevada State Water Engineer's supervision over of the Big  
6 Smoky Valley - Northern Part Groundwater Basin; and


7 WHEREAS, in order to generate the revenue needed to fund the budget the Board must levy a  
8 special assessment within the confines of the Big Smoky Valley - Northern Part Groundwater Basin as  
9 prorated and assessed against each water user who has a permit to appropriate water or perfected water  
10 right and the charge against each water user must be based upon the proportion which his or her water  
11 right bears to the aggregate water rights in the Big Smoky Valley - Northern Part Groundwater Basin,  
12 which said special assessment will generate approximately \$8,583.02.


13 NOW THEREFORE, BE IT RESOLVED, that effective for the 2018-2019 fiscal year there is  
14 hereby imposed a special assessment as prorated and assessed against each water user who has a permit  
15 to appropriate water or perfected water right within the Big Smoky Valley - Northern Part Groundwater  
16 Basin, to appear and be collected with the first quarter tax billing, which said special assessment shall be  
17 a lien upon the property.
