

1 **NYE COUNTY RESOLUTION NO. 2019-05**

2 A RESOLUTION DIRECTING THE LEVY OF A SPECIAL ASSESSMENT ON EACH WATER
3 USER SITUATED WITHIN THE CONFINES OF THE AMARGOSA VALLEY GROUNDWATER
4 BASIN FOR FISCAL YEAR 2019-2020

5 WHEREAS, pursuant to NRS 534.040(2) the Nye County Board of County Commissioners
6 (Board) is required to fund the 2019-2020 budget for Nevada State Water Engineer's supervision over of
7 the Amargosa Valley Groundwater Basin; and

8 WHEREAS, in order to generate the revenue needed to fund the budget the Board must levy a
9 special assessment within the confines of the Amargosa Valley Groundwater Basin as prorated and
10 assessed against each water user who has a permit to appropriate water or perfected water right and the
11 charge against each water user must be based upon the proportion which his or her water right bears to
12 the aggregate water rights in the Amargosa Valley Groundwater Basin, which said special assessment
will generate approximately \$13,216.53

13 NOW THEREFORE, BE IT RESOLVED, that effective for the 2019-2020 fiscal year there is
14 hereby imposed a special assessment as prorated and assessed against each water user who has a permit
15 to appropriate water or perfected water right within the Amargosa Valley Groundwater Basin, to appear
16 and be collected with the first quarter tax billing, which said special assessment shall be a lien upon the
17 property.
