

1 **NYE COUNTY RESOLUTION NO. 2020-01**

2 A RESOLUTION DIRECTING THE LEVY OF A SPECIAL ASSESSMENT ON EACH WATER
3 USER SITUATED WITHIN THE CONFINES OF THE DUCKWATER CREEK DISTRIBUTION
4 FOR FISCAL YEAR 2020-2021

5 WHEREAS, pursuant to NRS 534.040(2), the Nye County Board of County Commissioners
6 ("Board") is required to fund the 2020-2021 budget for Nevada State Water Engineer's supervision over
7 of the Duckwater Creek Distribution; and

8 WHEREAS, in order to generate the revenue needed to fund the budget the Board must levy a
9 special assessment within the confines of the Duckwater Creek Distribution as prorated and assessed
10 against each water user, which must be based upon the proportion which the water right of that water
11 user bears to the aggregate water rights in the Duckwater Creek Distribution, which said special
assessment will generate approximately \$9,330.00.


12 NOW THEREFORE, BE IT RESOLVED, that effective for the 2020-2021 fiscal year there is
13 hereby imposed a special assessment as prorated and assessed against each water user who has a permit
14 to appropriate water or perfected water right within the Duckwater Creek Distribution, to appear and be
15 collected with the first quarter tax billing, which said special assessment shall be a lien upon the
16 property.
