

1 **NYE COUNTY RESOLUTION NO. 2020-07**

2 **A RESOLUTION ENACTING THE SCHEDULE OF FEES REQUIRED FOR THE ANKLE**  
3 **MONITORING PROGRAM**

4 WHEREAS, on February 4, 2020 the Nye County Board of County Commissioners approved a  
5 contract with Track Group, Inc to set up an Ankle Monitoring Program, and;

6 WHEREAS, NRS 211.120 Allows the Nye County Sheriff to establish a program to release  
7 prisoners from the Nye County Detention Centers for work or education, and;

8 WHEREAS, NRS 211.280 provides that the Board of County Commissioners shall set an  
9 application fee and a daily fee for electronic supervision reasonable commensurate with its cost to the  
10 county, and;

11 WHEREAS, fees shall be set by resolution;

12 NOW, THEREFORE, BE IT RESOLVED by the Nye County Board of County Commissioners  
13 as follows:


14 1. That the schedule of fees required by NRS 211.280: Fees is set and shall be collected per  
15 the schedule of fees as shown in the attached Exhibit "A", which is incorporated herein by this  
16 reference.

**Exhibit A**

**Schedule of Fees for Equipment Deposit, Per Day Fee and Damages**

**A. Equipment Deposit Fee:                      \$100.00**

1.      This Fee is payable when signing up for this program.

**B. Hook Up Fee:                                      \$50.00**

1.      This Fee is payable when signing up for this program.

**C. Per Day Fee:                                      \$10/day**

1.      This fee must be paid by money order, cashiers check or credit card to the Nye County Sheriff's Office Program Administrator prior to being signed up for the program. You will be required to make a payment for the time period for which you are enrolling;
2.      If you are a sentenced inmate, you are eligible for making a one-time payment for the entire sentence or paying monthly. Payments not received by the first day of each month will result in your participation in the Electronic Monitoring Program being revoked and will result in immediate reincarceration;
3.      If you are not a sentenced inmate, then you will be required to enroll weekly or monthly. Payments not received by the first day of each month or weekly will result in your participation in the Electronic Monitoring Program being revoked and will result in immediate reincarceration.

**D. Damages Fee:**

**1.    Damage to Device:              \$1,400.00**

Damage to the device in ANY way will result in this fee.

**2.    Damage to Charger:              \$200.00**

Damage to the charger in ANY way will result in this fee.
