ADMINISTRATIVE ORDER

9 The judges of the Fifth Judicial District have various responsibilities, such
10 as supervising the administrative business of the district court, ensuring the quality
11 and continuity of court services, supervising the court calendar, reassigning cases
12 as convenience or necessity requires, assuring the court's duties are timely and
13 orderly performed, and otherwise facilitating the business of the district court.

14 On March 12, 2020, Governor Steve Sisolak declared a state of emergency
15 in Nevada in response to the recent outbreak of the Coronavirus Disease (COVID-
16 19). Given the severity of the risk posed to the public by COVID-19, and after
17 consultation with the Nevada Supreme Court Chief Justice Kristina Pickering, the
18 Fifth District Court has determined that alterations to court procedure are
19 necessary for the protection of the community.

20 During this time, the District Court will continue to accept filings and
21 continue to operate managing cases within the parameters set forth in this order.

2 Effective March 16, 2020, all current scheduled non-essential Court
3 hearings are ordered to be conducted by video or telephonic means; decided on
4 the papers; or rescheduled unless otherwise directed by the assigned Judge.

5 At this time, essential case types and hearings will continue to be heard
6 through in-person appearances, although appearance by alternative means under
7 Nevada Supreme Court Rule Part IX is encouraged when possible. Essential case
8 types and hearings include the following:

- 10 1. In-custody criminal sentencing, bail motions, and probation revocation
11 hearings until arrangements can be made to hear these matters by
12 alternative means;
- 13 2. Criminal arraignments;
- 14 3. Civil commitment cases;
- 15 4. Guardianship matters except for compliance related hearings which include
16 annual accountings. Given the vulnerability of the guardianship populations,
17 all protected persons shall appear by alternative means;
- 18 5. Domestic temporary or extended protection orders;
- 19 6. Juvenile delinquency matters;
- 20 7. Abuse and neglect preliminary protective hearings;
- 21 8. High-risk protective orders;
- 22 9. Civil temporary restraining orders and preliminary/permanent injunctive
23 relief hearings.
- 24 10. Probate petitions for orders of cremation.

2 11. Other than jury trials, case-by-case exceptions may be ordered at the
3 discretion of the assigned Judge.

4 12. Family Court matters involving emergency situations with children.

5
6 All jury trials, civil and criminal, scheduled in District Court for the next 30
7 days will be suspended and will be rescheduled as the court calendar allows. No
8 summonsed prospective jurors are to appear. Any currently ongoing jury trial will
9 finish.

11 This order shall operate to stay trial in civil cases for purposes of NRCP
12 41(e). The time period of any continuance entered as a result of this order shall
13 be excluded under for purposes of calculating speedy trial under NRS 178.556(1)
14 and NRS 174.511 as the Court finds the ends of justice served by taking that action
15 outweigh the interests of the parties and the public in a speedy trial. Absent further
16 order of the Court or any individual judge, the period of exclusion shall be from
17 March 16, 2020 through April 17, 2020. The Court may extend the period of
18 exclusion as circumstances warrant.

19
20 Additionally, the Centers of Disease Control has advised people to take
21 precautions and that the best way to prevent illness is to avoid exposure. As a
22 result, District Court Administration is ordered to post a notice at the entrance of
23 all district court facilities advising the following people that they may not enter the
24 court facility:

26 1. Persons who in the last 14 days have traveled to a country designated as a
27 Level 3 travel health notice according to the Centers of Disease Control and

2 Prevention. Currently those countries include: China, Iran, South Korea,
3 Austria, Belgium, Czech Republic, Denmark, Estonia, Finland, France,
4 Germany, Greece, Hungary, Iceland, Italy, Latvia, Liechtenstein, Lithuania,
5 Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Slovakia,
6 Slovenia, Spain, Sweden, Switzerland, Monaco, San Marino, Vatican City,
7 United Kingdom and Ireland; England, Scotland, Wales, Northern Ireland,
8 Republic of Ireland. The list is subject to change by the CDC.
9

10 2. Persons who reside or have close contact with someone who has travelled
11 to any foreign country within the last 14 days;
12 3. Persons who have been asked to self-quarantine by any doctor, hospital, or
13 health agency;
14 4. Persons who have been diagnosed with coronavirus or who has had contact
15 in the past 14 days with anyone who has been diagnosed with COVID-19;
16 or
17 5. Persons with unexplained fever, cough or shortness of breath.
18

19 Anyone attempting to enter in violation of these protocols will be denied entry by
20 District Court Bailiffs/Staff.
21

22 If a person is unable to appear in court because of the restrictions above,
23 the person may call the assigned court for assistance in rescheduling their court
24 appearance, arranging for appearance by alternative means or provide other
25 information based on the circumstances of the appearance.

2 This order shall be reviewed no later than every 30 days and shall continue
3 until modified or rescinded by a subsequent order.
