

1 **NYE COUNTY RESOLUTION NO. 2020-10**

2 A RESOLUTION DIRECTING THE LEVY OF A SPECIAL ASSESSMENT ON ALL TAXABLE  
3 PROPERTY SITUATED WITHIN THE CONFINES OF THE PAHRUMP VALLEY  
GROUNDWATER BASIN FOR FISCAL YEAR 2020-2021

4 WHEREAS, pursuant to NRS 534.040(2) the Nye County Board of County Commissioners  
5 (Board) is required to fund the 2020-2021 budget for Nevada State Water Engineer's supervision over of  
6 the Pahrump Valley Groundwater Basin, No. 162, in the amount of \$110,000.00; and


7 WHEREAS, in order to generate the revenue needed to fund the budget the Board must levy a  
8 special assessment at the rate of two dollars and seventeen cents (\$2.17) per taxable parcel of real  
9 property located within the Pahrump Valley Groundwater Basin, which said special assessment will  
10 generate approximately \$110,000.00 based on the current count of taxable parcels located within the  
11 Basin; and


12 NOW THEREFORE, BE IT RESOLVED, that effective for the 2020-2021 fiscal year there is  
13 hereby imposed a special assessment at the rate of two dollars and seventeen cents (\$2.17) on all taxable  
14 parcels of real property within the Pahrump Valley Groundwater Basin, to appear and be collected with  
15 the first quarter tax billing, which said special assessment shall be a lien upon the property.
