

1 NYE COUNTY RESOLUTION NO. 2020-23

2 A RESOLUTION DIRECTING THE LEVY OF THE TAX RATE REQUIRED FOR FISCAL YEAR
3 2020-2021

4 WHEREAS, the Nevada Tax Commission has certified the combined tax rates for the 2020-2021
5 fiscal year on June 25, 2020; and

6 WHEREAS, the Board of County Commissioners is required, pursuant to NRS 361.460, to levy
7 the tax rates for all local government entities in Nye County for the fiscal period beginning July 1, 2020,
8 and to designate the number of cents of each \$100 of property tax levied for each fund; and

9 WHEREAS, to confirm to the Nevada Department of Taxation the tax rates levied, the Department
10 of Taxation has requested county commissions to adopt the resolution levying the tax rates for all local
11 entities pursuant to NRS 361.460 and forward a copy of the Resolution to the Department;

12 NOW THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Nye
13 County, Nevada, hereby levy the tax rates for all local government entities in Nye County as such rates
14 have been certified by the Nevada Tax Commission;

15 BE IT FURTHER RESOLVED, that the tax rates for all local government entities in Nye County
16 for the fiscal year 2020-2021 as certified and levied are shown on the attached exhibits; and

17 BE IT FURTHER RESOLVED, that the tax rate for Nye County be designed and distributed for
18 each fund as shown on the attached exhibits; and

19 BE IT FURTHER RESOLVED, that the County Clerk is hereby directed to distribute copies of
20 this Resolution along with all attachments to the Nevada Department of Taxation, the Nye County
21 Treasurer, and Nye County Comptroller, and the Nye County Managers Office.
