

1 **NYE COUNTY RESOLUTION NO. 2021-07**

2 A RESOLUTION AUTHORIZING THE SUBMITTAL OF A PROPOSAL OR PROPOSALS WITH
3 THE NEVADA DEPARTMENT OF TRANSPORTATION (NEVADA DOT) FOR GRANTS
4 THROUGH THE U.S. DEPARTMENT OF TRANSPORTATION (USDOT) FEDERAL TRANSIT
5 ADMINISTRATION (FTA), AS AUTHORIZED UNDER FEDERAL TRANSIT LAW AND FUNDS
6 AVAILABLE FROM THE NEVADA PUBLIC TRANSPORTATION GRANT PROGRAM AND
7 EXECUTING A CONTRACT WITH THE NEVADA DEPARTMENT OF TRANSPORTATION UPON
8 GRANT PROPOSAL ACCEPTANCE.

9 WHEREAS, the Director of the Nevada Department of Transportation is authorized to make grants
10 for a public transportation program; and

11 WHEREAS, the contract for financial assistance will impose certain obligations upon the
12 Applicant, including the provision by it of the local share of the project costs in the program; and

13 WHEREAS, it is required by the U.S. Department of Transportation in accordance with the
14 provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application
15 for assistance, that the Applicant give an assurance that it will comply with Title VI of the Civil Rights
16 Act of 1964 and the U.S. Department of Transportation requirements thereunder; and

17 WHEREAS, it is the goal of the Applicant that disadvantaged business enterprise be used to the
18 fullest extent possible in connection with this/these project(s), and that definite procedures shall be
19 established and administered to ensure that disadvantaged businesses shall have the maximum
20 construction contracts, supplies, equipment contracts, or consultant and other services.

21 NOW, THEREFORE, BE IT RESOLVED BY the Nye County Board of County Commissioners:


- 22 1. Nye County is authorized to execute and submit an application on behalf of APPLICANT
23 with the Nevada DOT to aid in the financing of capital and operating assistance projects
24 and the Nevada Public Transportation Grant Program.
- 25 2. Nye County is authorized to execute and file with such application and assurance or any
other document required by the USDOT effectuating the purposes of Title VI of the Civil
Rights Act of 1964.

1 3. Nye County is authorized to furnish such additional information as the Nevada DOT may
2 require in connection with the application for the program of projects submitted to FTA.
3 4. Nye County is authorized to set forth and execute affirmative disadvantaged business
4 policies in connection to any procurement made as part of the project.
5 5. Nye County is authorized to execute grant agreements on behalf of APPLICANT with the
6 Nevada DOT for aid in the financing of operating and capital assistance projects.

7 The undersigned duly qualified and acting Chairman of the Nye County Board of County Commissioners
8 certifies that the foregoing is a true and correct copy of a resolution, adopted at a legally convened meeting
9 of the Nye County Board of County Commissioners held on March 16, 2021.
