This letter shall serve as agreement between Northern Nye County Hospital District Board of Trustees (Board) And Combination Seven LLC, dba Mizpah Hotel (Mizpah) to rent an office located in the Annex section of the property.

- The office space is located on the 2nd floor of the Mizpah Annex.
- The office space is only accessible via staircase
- The office space is unfurnished. The Board will provide necessary furnishings, equipment and services to run their operation.
