

1 **NYE COUNTY RESOLUTION NO. 2021-35**

2 **A RESOLUTION AUTHORIZING THE NYE COUNTY TREASURER TO ESTABLISH A**  
3 **CHECKING ACCOUNT THROUGH NEVADA STATE BANK**

4 WHEREAS, on September 21, 2021 the Nye County Comptroller requested that the Nye County  
5 Board of County Commissioners (Board) authorize the establishment of a checking account for the  
6 Public Guardian; and

7 WHEREAS, Per NRS 253.243 the Public Guardian may request an advance of money to pay  
8 necessary expenses of during guardianship;

9 WHEREAS, the Board finds that sufficient cause exists to justify the opening of said checking  
10 account.

11 NOW THEREFORE, BE IT RESOLVED by the Nye County Board of County Commissioners  
12 as follows:

- 13 1. The Nye County Treasurer is hereby authorized to establish a checking account with Nevada  
14 State Bank, for an advance of money to pay necessary expenses incurred, or to be incurred,  
15 by the Public Guardian during a guardianship.
- 16 2. The Nye County Treasurer is directed to transfer from the General Fund the sum of Ten  
17 Thousand (\$10,000) to establish the account.
- 18 3. All checks written on the said checking account shall be signed by the Public Guardian or  
19 Chief Deputy Public Guardian. The Nye County Comptroller will serve as a backup signer in  
20 an emergency. The Nye County Comptroller shall maintain a listing of signers on the Public  
21 Guardian bank account and shall update the bank with any modifications to signers on the  
22 account.

23 The Public Guardian, Chief Deputy Public Guardian, or designee shall submit reimbursements to Nye  
24 County Treasurer no less than once monthly by the 5<sup>th</sup> of the month. The reimbursement request shall  
25 include a full bank account reconciliation.
