

1 **NYE COUNTY RESOLUTION NO. 2021-36**

2 A RESOLUTION DIRECTING THE COUNTY ASSESSOR TO PREPARE A LIST OF THE  
3 TAXPAYERS ON THE 2022-2023 SECURED TAX ASSESSMENT ROLL IN NYE COUNTY,  
NEVADA AND DIRECTING DISTRIBUTION OF THE SAME.

4 WHEREAS, pursuant to NRS 361.300(3) the County Assessor is required to prepare a list of all  
5 property owners and the total value of property owned within the County prior to December 1<sup>st</sup> of the  
6 current fiscal year; and

7 WHEREAS, the list of property owners and the total value of the property owned by each  
8 individual has been compiled for the tax year beginning July 1, 2022 to June 30, 2023; and

9 WHEREAS, NRS 361.300(3) requires notification on or before January 1<sup>st</sup> of the fiscal year to  
10 each taxpayer in the County of the total valuation of his property; and

11 WHEREAS, NRS 361.300(3) permits notification through publication in a newspaper of general  
12 circulation in the County, or by delivering or mailing the appropriate notice to the taxpayer, or by  
13 publishing on the internet website that is maintained by the county assessor, or if the county assessor  
14 does not maintain an internet website, on an internet website that is maintained by the county.

15 NOW THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Nye  
16 County, State of Nevada hereby directs the Nye County Assessor to prepare a list of all the taxpayers on  
17 the secured roll in the County and the total valuation of property on which they severally pay taxes, and  
18 either to:


- 19 1. Cause such list and valuations to be printed and delivered or mailed on or before January 1,  
20 2022 to each taxpayer in the County; or
- 21 2. Cause such list and valuations to be published once on or before January 1, 2022 in a  
22 newspaper of general circulation in the County; or
- 23 3. Published on an internet website that is maintained by the County Assessor; and
- 24 4. Cause such list and valuation to be posted at the office of the County Assessor and in a public  
25 area of the public libraries located in the County.

1 BE IT FURTHER RESOLVED, that the Board of County Commissioners directs the County  
2 Assessor:

- 3 1. The Nye County Assessor is authorized not to deliver or mail the list of all the  
4 taxpayers on the secured roll to taxpayers whose property is assessed at \$1,000 or  
5 less. However, should the Assessor choose not to mail the list to each taxpayer whose  
6 property is assessed at \$1,000 or less, each of those taxpayers shall be mailed a  
7 statement of the amount of his assessment.
- 8 2. If the Nye County Assessor publishes the list and valuation on the internet website  
9 then he or she shall also provide notice in a newspaper of general circulation in the  
10 county each year the information required pursuant to NRS 361.300(3)(d); and
- 11 3. TO make not fewer than 10 copies of such list and valuations available to the public  
12 free of charge during normal business hours at the main administrative office of the  
13 County for at least 60 days after the date on which the list and valuations are made  
14 available to the public.


