2 A PROCLAMATION RECOGNIZING MAY 2023 AS NEVADA WILDFIRE AWARENESS  
MONTH IN NYE COUNTY

3 WHEREAS, wildfire significantly impacts Nevada's environmental, economic, and social well-being; and

5 WHEREAS, residents must prepare to survive wildfire by ensuring proper management of  
6 vegetation surrounding the home and appropriate home construction and maintenance to resist ignition;

8 WHEREAS, residents need to work together to prepare their homes and communities to survive  
9 wildfire and commit to becoming fire adapted; and

10 WHEREAS, residents can save precious time in an evacuation by preparing a go-bag and A  
11 family evacuation plan ahead of time; and

12 WHEREAS, this year's Nevada Wildfire Awareness Campaign is themed "Protect Our Home,  
13 Prepare for Wildfire," as a means for education and a call for residents of Nye County to work together  
14 to be ready for wildfire.
