On March 23, 2022 the Board of Nye County Commissioners (BoCC) allocated the Nye County Water District \$285,000.00 for a Cloud Seeding Program to encourage rain in southern Nye County for an increase of the recharge rate to the Pahrump Valley aquifer located in Hydrographic Basin #162.		
The Nye County American Rescue Plan Act (ARPA)- Recovery Plan and Policy was approved by the BoCC during the September 20, 2022, which authorized Infrastructure Grant funding for the Nye County Water District Cloud Seeding Program.



Spring Mountains Cloud Seeding Weather (based on climatological analysis of winter storms)

Clouds containing subfreezing water drops.


12,000' MSL temperatures less than 23°F

DRI Remote Cloud Seeding generator







Winter 2022-2023 review and monthly seeding operations




Cumulative WY23 Spring Mountains SWE Compared to 30-year maximum SWE




November 2022 – 2.4" of total SWE,




December 2022 – 1.3" of total SWE,




January 2023 – 7.8" of total SWE,

20230201 to 20230301




February 2023 – 2.7" of total SWE,








Confirming targeting using trace chemistry – snow collection




Ground Water Recharge in Basin 162
