Measurable outcomes for this project include number of patients served, number of services provided, the \$ value of care, the number of volunteers, etc. For both the Tonopah clinic as well as the Pahrump clinic, all metrics were either met or exceeded. The Tonopah clinic especially exceeded our expectations. We did not know what to expect with it being the first clinic in Tonopah, but even with setting aggressive goals, all metrics were still exceeded. Beyond the usual hiccups and snags experienced with any large scale event, we did not face any extraordinary challenges for either the Tonopah or Pahrump clinic.

While the metrics speak for themselves and tell an impactful and inspiring story, the total impact that this program has had on Pahrump and Tonopah is immeasurable. The stories we hear each year about how important and life changing the services received at RAM are, the stories from volunteers who have become inspired to serve in other ways within the community, and the support we receive tell the real story of the impact of these clinics.

Our project has been running for 10 years and has survived each year with a variety of funding sources. The support through this grant is very much appreciated and we are happy to report that "the show will go on", even without the renewal of this grant.
