1 **NYE COUNTY RESOLUTION NO. 2025-12**

2 A RESOLUTION DIRECTING THE LEVY OF A SPECIAL ASSESSMENT ON EACH WATER USER
3 SITUATED WITHIN THE CONFINES OF THE GROUNDWATER BASINS WITHIN NYE COUNTY FOR
4 FISCAL YEAR 2025-2026.

5 WHEREAS, pursuant to NRS 534.040(2), the Nye County Board of County Commissioners
6 (“Board”) is required to fund the 2025-2026 budget for the Nevada State Water Engineer’s supervision
7 of the Upper Reese River Valley, White River Valley, Amargosa Valley, and Big Smoky Valley –
8 Tonopah Flat Groundwater Basins; and

9 WHEREAS, in order to generate the revenue needed to fund the budget the Board must levy a
10 special assessment within the confines of the Upper Reese River Valley Groundwater Basin as prorated
11 and assessed against each water user who has a permit to appropriate water or perfected water right and
12 the charge against each water user must be based upon the proportion which his or her water right bears
13 to the aggregate water rights in the Upper Reese River Valley Groundwater Basin, which said special
14 assessment will generate approximately \$2,166.67.

15 WHEREAS, in order to generate the revenue needed to fund the budget the Board must levy a
16 special assessment within the confines of the White River Valley Groundwater Basin as prorated and
17 assessed against each water user who has a permit to appropriate water or perfected water right and the
18 charge against each water user must be based upon the proportion which his or her water right bears to
19 the aggregate water rights in the White River Valley Groundwater Basin, which said special assessment
20 will generate approximately \$1,538.81.

21 WHEREAS, in order to generate the revenue needed to fund the budget the Board must levy a
22 special assessment within the confines of the Amargosa Valley Groundwater Basin as prorated and
23 assessed against each water user who has a permit to appropriate water or perfected water right and the
24 charge against each water user must be based upon the proportion which his or her water right bears to
25 the aggregate water rights in the Amargosa Valley Groundwater Basin, which said special assessment
will generate approximately \$22,912.05.

1 WHEREAS, in order to generate the revenue needed to fund the budget the Board must levy a
2 special assessment within the confines of the Big Smoky Valley – Tonopah Flat Groundwater Basin as
3 prorated and assessed against each water user who has a permit to appropriate water or perfected water
4 right and the charge against each water user must be based upon the proportion which his or her water
5 right bears to the aggregate water rights in the Big Smoky Valley – Tonopah Flats Groundwater Basin,
6 which said special assessment will generate approximately \$10,667.46.

7 NOW THEREFORE, BE IT RESOLVED, that effective for the 2025-2026 fiscal year there is
8 hereby imposed a special assessment as prorated and assessed against each water user who has a permit
9 to appropriate water or perfected water right within the Upper Reese River Valley, White River Valley,
10 Amargosa Valley, and Big Smoky Valley – Tonopah Flat Groundwater Basins, to appear and be
11 collected with the first quarter tax billing, which said special assessment shall be a lien upon the
12 property.

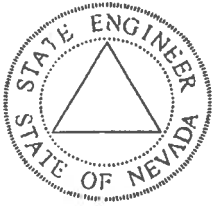

To Whom It May Concern:

Pursuant to the provisions of NRS 534.040(3), it is respectfully requested that you levy a special assessment on the water right holders listed in the enclosed documents, which are located in the confines of the Groundwater Basins within Nye County, for the Fiscal Year July 1, 2025, to June 30, 2026. The levy must be charged against each water user who has an active water right or claim of vested right, and the charge against each water user must be based upon the proportion which their water right bears to the aggregate water rights in the subject hydrographic basin.
