a. Approve or reject the addition of three (3) Road Maintenance Worker III positions; and

b. Fund from 10510 Landfills

BACKGROUND

Nye County Public Works currently operates landfill facilities seven days a week with two (2) employees working alternating schedules at the Tonopah Landfill. Historically, the department has encountered challenges in attracting and retaining qualified personnel for landfill operations.

Request for additional Road Maintenance Worker III positions -

New landfill fees are being implemented on 7/1/2025 which will involve additional load inspections and payment collection at the Tonopah and Round Mountain Landfills.

The current operator of the Round Mountain Landfill will no longer be under contract on 7/1/2025. To continue operating the Round Mountain Landfill after 7/1/2025 and implement the new fees, additional staffing is necessary to manage increased operational demands, including load inspections and payment collection.

We request the addition of three (3) Road Maintenance Worker III positions: two (2) for the Tonopah Landfill and one (1) for the Round Mountain Landfill.

Fiscal Impact:

- Road Maintenance Worker III (Grade 9, Step 1):
 - Total Compensation per Position:
Salary - \$43,326.40 / Benefits - \$53,070.52 / Total - \$96,396.92
 - Total for Three Positions: \$289,190.76

Without these new positions, we will not be able to efficiently operate the Landfills. We will need request existing Road Maintenance Workers to cover the landfills until positions are filled.

Conclusion

This addition of staff is critical toward ensuring efficient landfill operations and accommodating future operational changes.

Fiscal Impact: Total projected increase = \$289,190.76

This will be funded through Fund 10510, Landfills.

Recommendations: Staff recommends approving the additional Road Maintenance Worker III positions.
