The U.S. Department of Housing and Urban Development (HUD) has made approximately \$2,800,000 available to the State of Nevada through the CDBG Program.



There is \$200,000 less grant funds available for the 2026 application period compared to last year.

CODE OF FEDERAL REGULATIONS

TITLE 24 § 570.488

As a condition of receiving Community Development Block Grant funding through the Department of Housing and Urban Development, Nye County must take reasonable measures to minimize the displacement of families and individuals from their homes and neighborhoods.


Any federally funded project involving the acquisition, rehabilitation or demolition of real property which results in the displacement, relocation, or replacement of lower-income housing would require Nye County to:

**Certify and Adopt a Residential Antidisplacement
and Relocation Assistance Plan**

**Offer One-for-One Replacement of Existing
Housing**
