**RELIGIOUS OFFICIAL
INSTRUCTIONS FOR TEMPORARY REPLACEMENT
CERTIFICATE OF PERMISSION TO PERFORM MARRIAGES
(For Applicant who resides within Nye County)**

**PLEASE NOTE: IT IS UNLAWFUL TO SOLEMNIZE MARRIAGES
BEFORE YOU OBTAIN A CERTIFICATE OF PERMISSION**

The following documents are required when applying for authorization:

1. **Application for a Temporary Replacement Certificate of Permission to Perform Marriages in the State of Nevada** (Must be signed before a Notary Public or Deputy County Clerk)
2. **Affidavit of Authority to Solemnize Marriages** (must be signed by someone in your church or religious organization that has authority to speak on behalf of your church or religious organization and can verify that you are in good standing within that church or religious organization. (This cannot be signed by the applicant.))
3. **Written Authorization** from the minister or other church or religious official authorized to perform marriages who you are temporarily replacing stating the period of time temporary replacement is to be effective. The replacement period must not exceed 90 days.
4. **Photo Identification** (i.e. Driver's License, Passport, etc.)
5. **Release and Authorization for Background Investigation**
6. **Application Fee of \$30.00 effective December 1, 2021** (Payable to Nye County Clerk, cash, cashier's check or money order. This fee is non-refundable)

Please Note: All paperwork should be returned to this office at one of the addresses listed below. (Do NOT return the instruction sheet.) Item No. 5, will be forwarded to the Nye County Sheriff's Office for the background check. The background check will be completed within approximately 7 business days and the report will be forwarded to the Nye County Clerk. Upon receipt of the background check report, the County Clerk will review all documents. If everything is in order, the Certificate of Permission to Perform Marriages should be completed within 5 – 7 business days after receipt of the background check report.

If approved, the Certificate will be mailed to **the residence address listed on the application**, along with an Information Sheet for Officiant which provides information on completing the marriage certificate. If you would like to arrange to pick up the Certificate or to have it mailed to a different address, please include the instructions with the application paperwork. The Certificate cannot be sent via express mail unless a self-addressed, pre-paid express mail envelope is enclosed.

If the application is not approved, you will receive a letter explaining why it was not granted.

Normal processing time for applications **after receipt of background check report** is 5 - 7 business days. **PLEASE ALLOW SUFFICIENT TIME FOR PROCESSING IF YOU ARE TO SOLEMNIZE A WEDDING IN THE NEAR FUTURE (sending paperwork 3 to 4 weeks in advance is recommended).**

Paperwork must be filled out completely and properly signed and notarized. **DO NOT LEAVE BLANK SPACES. PAPERWORK THAT IS INCOMPLETE OR INCORRECT WILL DELAY THE PROCESS AND/OR MAY RESULT IN THE CERTIFICATE BEING DENIED.**

5. If the aforementioned church or religious organization changes address or location; or
6. If the church or religious organization is dissolved or otherwise terminated or changes its existence.

WAIVER AND AUTHORIZATION FOR RELEASE OF INFORMATION

In connection with my application for Authorization to Solemnize Marriages in the State of Nevada pursuant to NRS 122.064, subsection 3 (c), I hereby authorize Cori A. Freidhof, Nye County Clerk, and the Nye County Sheriff's Office to perform a background screening check (including future screenings for retention, if applicable, and unless revoked by Applicant in writing). I understand and agree to the following:

1. A background check is not only for the benefit of the Nye County Clerk as a sound business practice, but also for the benefit of the public. It is no reflection on an applicant. The report consists of information deemed to have a bearing on the decision to grant authorization to solemnize marriages in the State of Nevada, and may include information from public and private sources and public records. The scope of the report may include information concerning civil and criminal court records, identity, past addresses and social security number and is conducted in accordance with applicable federal and state laws.
2. All reports are confidential, and provided to the Nye County Clerk for decisions concerning authorization to solemnize marriages only.
3. I may review or obtain a copy of my report as provided by law.
4. I authorize and release people, companies, municipal, county, state and federal agencies and courts to provide all information that is requested to the Nye County Clerk or the Nye County Sheriff's Office.
5. I further release all of the above, including the Nye County Clerk and the Nye County Sheriff's Office, to the full extent permitted by law, from any liability or claims arising from retrieving and reporting information concerning me.
6. I agree that a copy or fax of this document shall be as valid as the original.

I hereby consent and authorize the Nye County Sheriff's Office, on the Nye County Clerk's behalf, to prepare each report as defined above to assist in making decisions relating to granting authorization to solemnize marriages in the State of Nevada, before such decision to grant authorization or any time after such authorization.

I understand that I have a right to receive a copy of this authorization and acknowledge that I have received a copy of it.
