This will only authorize funding and will only authorize removal of RVs/trailers on the land of another, with express permission from the owner of the land that the RVs/trailers do not belong to them. All proper/legal paperwork will be followed during that process. This only authorizes funding.

It is suggested that 75% come from the Town of Pahrump budget and 25% from Nye County.

\$35,000 in funding

- Passage of \$35,000 from grant or other sources (no new taxes)
- \$35,000 would significantly clean up our mountain views of unsightly homeless camps/illegal RVs and trailers

REMOVES HOMELESS/SQUATTERS PERMANENTLY

This funding will fund the seizure of "mobile homes" that are unlawfully providing dangerous housing for nonresidents. These are not safe places for people to live and attract crime.

This removes a source of housing that attract people from outside Nye County to come and illegally squat and occupy.

Owners will be notified and have an opportunity to claim their property through procedure already written in law. Only trailers and RVs placed illegally on land of another will be removed through this funding.

Hello Commissioner Bayne,

I'm writing to memorialize our recent phone conversation regarding the enforcement of parking violations involving RVs.

As discussed, **if sufficient funding were available**, the **Nye County Sheriff's Office (NCSO)** would have the ability to **tow illegally parked RVs from public property**. Additionally, NCSO could remove such vehicles from **private property**, provided that the **property owner gives consent**.
