**Party Change Deadline:** PURSUANT TO NRS 293.176(1), No person may be a candidate of a major political party for partisan office in 2026 if he or she changed political affiliation to Democratic or Republican on a Voter Registration Application in Nevada or in any other state on or after December 31, 2025.

**Judicial Candidate Filing is January 5-16, 2026, Weekdays 8:00 a.m. to 5:00 p.m.**  
Pursuant to SB418 (2023), certain judicial candidates are now required to fill out and submit a questionnaire during the filing period. This is available at <https://www.nvsos.gov/sos/elections>.

**The last day to withdraw judicial candidacy is January 28, 2026, by 5:00 p.m.**

**Non-Judicial Candidate Filing is March 2-13, 2026, Weekdays 8:00 a.m. to 5:00 p.m.**  
No person may be a candidate unless he/she actually, as opposed to constructively, resided in the district to which the office pertains for at least the 30 days immediately before the close of candidate filing.

**Last day to withdraw candidacy (non-judicial) is March 24, 2026, by 5:00 p.m.**

**Candidates Must Present One of the Following Forms of Identification When Filing for Office:** Government-issued valid driver's license or identification card issued by a governmental agency containing your photograph and physical address, a current utility bill, bank statement, paycheck, or government -issued document, such as a check, containing your name and physical address.

**Filing Fees.** The filing fee for any county office is \$105.00. Any district office is \$35.00. Uncompensated positions have no fee. Filing fees are payable by cash, cashier's check, or money order.
