## GENERAL INFORMATION SUMMARY

Court Services Division at the Pahrump Justice Court comes into contact every day with individuals both in and out of custody, and they see how the “homeless” population is growing in our community. In light of this, they made county management aware of an ongoing situation developing in Pahrump involving the homeless and Sober Homiez.

As individuals check in with Court Services, they often have to provide information about where they live, and during the interaction, additional information is often volunteered about what they are currently doing. As it turns out, many of the individuals are former residents of Las Vegas, but now homeless. How does this happen? Well, it would seem that many are transported to the Sober Living Homes offered by Sober Homiez, and once their Medicaid limits are exhausted, Sober Homiez more or less kicks them out. The individuals have no means to return to Las Vegas, which in turn causes them to become homeless in Pahrump and accumulate at our parks, which causes additional issues.

It was approximately a year ago when the Court Services Division was approached by Sober Homiez to promote their programs. Before they made any determination, they conducted research and found that the Managers at that time had active warrants in the greater Las Vegas area; that aside, they determined their programs were not compatible with the court's requirements.

Court Services understands the need for a good facility locally, and perhaps the program they are offering is good and may be needed by some, but due to ongoing issues, Court Services will not be using them.
