NYE COUNTY ORDINANCE NO. ____

SUMMARY: A Bill proposing to amend Nye County Code Chapter 2.22, Railroad Valley Advisory Board, by staggering the terms of the members; and other matters properly related thereto.

TITLE: A BILL PROPOSING TO AMEND NYE COUNTY CODE CHAPTER 2.22, RAILROAD VALLEY ADVISORY BOARD, BY STAGGERING THE TERMS OF THE MEMBERS; AND OTHER MATTERS PROPERLY RELATED THERETO.

WHEREAS, pursuant to NRS 244.1945, the Nye County Board of Commissioners (BOCC) has the authority to establish by ordinance advisory boards for any purpose relating to the County about which the BOCC desires advice; and

WHEREAS, on December 1, 2009, the Nye County Board of Commissioners requested to stagger the terms of the members of the Railroad Valley Advisory Board (Advisory Board).

NOW, THEREFORE, the Board of County Commissioners of the County of Nye, State of Nevada, does hereby ordain as follows:

NYE COUNTY CODE TITLE 2.22 IS HEREBY AMENDED BY AMENDING CHAPTER 2.22.020 AS FOLLOWS:

2.22.020 Terms of Members, Removal, and Replacement.

~~A. All members appointed to the Advisory Board will serve two (2) year terms. A member may be reappointed to the Advisory Board, without limit on the number of terms served.~~ At the expiration of the Advisory Board members' terms in 2011, the BOCC shall appoint five (5) members to the Advisory Board to terms as follows:

1. Two (2) members for terms of no more than one year; and

~~A.2.~~ Three (3) members for terms of more than one year but no more than two years.

A member may be reappointed to the Advisory Board, without limit on the number of terms served.

B. Upon the occurrence of a vacancy on the Advisory Board, due to the resignation or death of any member, removal or any other reason, the BOCC will appoint a qualified person to serve the remainder of the term.

- C. The BOCC shall have the authority to remove any member of the Advisory Board, if the BOCC finds that his or her removal is in the best interest of the Advisory Board and/or the residents of the communities served by the Advisory Board.
